Guiding Principles





The First 4 Weeks (Possibly 8 weeks) in SISD

Students and Parents will choose the desired learning environment through a Pre Registration Process.

All student instruction will be remote for the first four weeks.

Those students who complete an application and are accepted to the Cardinal Online Academy will be enrolled in the Academy and commence online learning on **DAY ONE**.

Students who choose the Cardinal Schoolhouse Academy or the Cardinal Half and Half Academy will be in virtual classes for at least the first four weeks of school (this may be extended as Local Health conditions warrant).

Special Education Support and Guidelines

How does the district intend to support students in Special Education? To the extent possible, the District will continue to implement your child's IEP, through remote delivery models. For some students, remote learning may not result in full implementation of your child's IEP. If your child's IEP cannot be fully implemented during remote instruction, your child's ARD committee will determine which services it can provide to meet the student's needs. Available remote instructional models include synchronous instruction through Google Meet/Classroom and asynchronous assignments that provide for the implementation of your child's IEP goals and accommodations/modifications.

Special Education Support and Guidelines

• What type of Professional Development will teachers and support staff receive to be better prepared this year?

Teachers and support staff will be provided training on the best practices of Special Education and Section 504, how to access students' IEP/504 plans, and the expectations of implementation of the plans on the online platforms.

• Explain ARD Meeting protocols and parent meetings.

Whenever possible, ARD meetings will be convened remotely by video conference and telephone to permit recommended physical distancing. These meetings will be convened annually and may be convened more often at the request of parents or teachers to revise the student's IEP and any lack of expected progress.

English Language Learner Support and Guidelines

- The Language Proficiency Assessment Committee (LPAC) Meetings will continue virtually.
 - Meetings are required by law and will always offer parents the opportunity to participate in the decision making process.
- SISD is a Dual Language District
 - We will continue to offer the program as such in the upcoming year.
 - Specific information regarding testing and student selection will be shared soon.

Meal Guidelines

- The District Child Nutrition Department will provide Breakfast and Lunch Starting August 17, 2020
- Meals will be served at all campuses as Curbside Grab N Go Meals from 11:30 am 1:30 pm
- 10 Buses will deliver meals to communities (Schedules will be posted on CN Webpage, District webpage and Transportation Webpage)
- Meal Distribution Days: Monday & Wednesday
 - Monday: Meals for Monday, Tuesday and Wednesday
 - Wednesday: Meals for Thursday and Friday
- All Child Nutrition Employees will have a daily temperature check at time of arrival and at mid shift. We all will be wearing masks to protect the community and ourselves.
- Students receiving meals or parents picking up meals for students must present a student ID or a registration letter stating school they are attending. No Exceptions. This is a Texas Department of Agriculture TDA requirement.

Extracurricular Activities

- No in-person extracurricular activities will be offered until in-person instruction will be available.
- Extracurricular activities from sports to fine arts will be offered virtually.
- TEA/UIL guidelines will be followed for our extra-curricular activities

Campus Visitor Guidelines

- Visitors will be able to come to campus by making an appointment only. Virtual meetings will be scheduled.
